Thank you for being a part of the Steelville Arts Council (a 501C3 non-profit organization) where we will be offering for sale your hand-crafted creations at Heartland Arts located in the Evan's House.

#### **Time and Place of Shoppe:**

303 Main Street, Steelville, Mo. 65565

Hours: Thursday, Friday, Saturday and Sunday 10 a.m. to 4 p.m.

#### **Compensation is available in 2 ways and paid monthly.**

##### **Commission:**

60% (artisans) non-STARCO members / 40% (STARCO)

70% (artisans) STARCO members in good standing / 30% (STARCO)

80% (artisans) STARCO members in good standing with 9 hours of volunteer work at Heartland Arts per month / 20% (STARCO)

#### **Or**

##### **Flat Fee:** 100% of sales to artisans

With a \$30 monthly fee for non-STARCO members

With a \$20 monthly fee for STARCO members in good standing

With a \$10 monthly fee for STARCO members in good standing plus 9 hours volunteer work at Heartland Arts per month

(STARCO yearly memberships start at \$35)

##### **Sales:**

Steelville Arts Council will handle sales and sales tax. They will be processed through Yadkin Creek Mercantile who will provide a check for compensation of any sales.

##### **A complete inventory with price list must be provided on the day of delivery of your creations to Heartland Arts.**

##### **Conditions of Entry:**

All two-dimensional pieces must be framed with a wire securely fastened across the back. No saw-tooth hangers, please.

Creations must be original artwork and not over 2 years old. (No reproductions or manufactured goods.)

Heartland Arts is a family friendly venue and the Steelville Arts Council reserves the final approval of all creations to be sold.

**Displays:**

Please indicate the type of display needed; if you will be providing a display fixture please advise what type of fixture. If your items require wall space please advise how much is required.

**Liability:** STARCO will take the utmost care of your work and do our best to protect it at all times. STARCO will be liable for any loss or damage to the works while they are for sale at Heartland Arts up to the amount owed to artisan according to their contract. Liability shall not exceed the maximum stipulated in the Steelville Arts Council insurance policy.

We reserve the right to release for publicity purposes: (i.e. publications) any information or photographs pertaining to the items submitted to STARCO for our gift shop.
